## **ALPHA SPECTRA LIMITED WARRANTY**

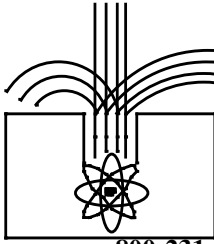
Alpha Spectra, Inc. scintillation detectors are manufactured with the highest quality standards. Alpha Spectra, Inc. warrants to the original purchaser of each scintillation detector, that should the detector prove defective due to improper workmanship or material, for a two-year period from the date of shipment, Alpha Spectra, Inc. will repair or replace, at its option, any defective detector without charge for the replacement detector. To obtain this warranty service the customer must deliver the detector to Alpha Spectra, Inc. at its address below. Shipping expenses are the customer's responsibility. Proof of purchase may be required when requesting this warranty service.

All Alpha Spectra, Inc. detectors are designed for use in a normal laboratory environment. When used in a normal laboratory environment, all Alpha Spectra, Inc. scintillation detector assemblies carry a two-year warranty against detector malfunctions due to faulty construction or failure to the hermetic seal(s). Scintillation detectors designed for use in normal laboratory environment will operate reliably between 40 °F (5 °C) and 120 °F (50 °C) provided the rate of temperature change does not exceed 15 °F/hr (8 °C/hr). Any detector assemblies designed for use in field applications where severe thermal and mechanical shock conditions exist will be covered by separate specifications under terms agreed upon by Alpha Spectra and the customer.

Detectors that are provided with a photomultiplier tube will carry the manufacturers' warranty extended from date of shipment from Alpha Spectra, Inc.

Each Alpha Spectra, Inc. detector assembly is tested prior to shipment and is accompanied by a "SCINTILLATION DETECTOR QUALITY ASSURANCE REPORT" showing the performance specifications of the detector at the time of shipment. These records are permanently maintained by Alpha Spectra for all future reference. It is advised that the customer also maintain a copy of this report.

This warranty does not cover defects caused by: (1) modification, alteration, repair, or service of the scintillation detector by anyone other than Alpha Spectra, Inc. or its representatives; (2) physical abuse to, or misuse, of the detector; or (3) shipment of the detector. This warranty excludes all costs other than the cost of the detector.
